Using your grace period: Extend your time for CCB certification renewal

Is your renewal deadline right around the corner? Struggling to get those last few compliance-related CEUs? You can extend the time you have to get the CEUs you need.

CCB certifications expire two years from the month you originally passed your CCB certification exam. To renew your certification, you must earn and submit 40 CCB CEUs (20 from live training events) within those two years and pay the renewal fee.

But what happens when your renewal deadline is approaching, and you don't have enough CEUs to renew? Or what if your company has a put a hold on staff attending outside conferences to earn their continuing education? Then what do you do? CCB is aware of these difficulties that our certificants face, and we want to be sure you take advantage of all the opportunities we offer to help you to maintain your CCB certification.

- 2 Utilize CCB's one-month grace period. The grace period is the month following the last day of your current renewal cycle.

For example, if your renewal period runs from August 1, 2020 to July 31, 2022, then your grace period is the period from August 1, 2022, to August 31, 2022. You do not need to contact CCB in order to use this additional time to earn your CEUs.

If you are near exhausting your grace period, you can file a "<u>Renewal Extension Request</u>." This can give you an additional one or two months beyond your grace period to gain CEUs needed for renewal. On this Renewal Extension Request form you will indicate if you need a one-month or two-month extension.

For example, if your renewal period runs from August 1, 2020 to July 31, 2022, your grace period would run from August 1, 2022, to August 31, 2022, and you could extend your renewal cycle up to October 31, 2022.

A \$50 monthly extension fee applies. The renewal extension is only available for certification holders' most recent active renewal period. Individuals who need to use the grace or extension periods should note that their next renewal date will be less than 24 months away and will still require accumulation of 40 CCB CEUs in that reduced period of time.

To complete a renewal extension request form go <u>here</u>. Please allow us five business days to process the extension request once it is received.

Using the grace period and the renewal extension allows you to extend your original certification end date for up to three months. However, if all required CEUs are not earned by this end date, your certification will lapse and retesting may be your only option to regain the certification.

FAQ: Live vs. non-live credits. What is the difference, and why is it important?

Live CEUs are earned when an instructor or facilitator presents educational content in real-time. As long as the education is being broadcast and received in real-time with the ability to interact with Q & A, then the education is considered live. Examples include in person conferences, real-time webinars or virtual conferences, and speaking at an event.

Non-live CEUs are earned when an educational event is not interactive, such as pre-recorded audio or video, authoring an article, reading an article and passing a quiz, etc. These educational activities must be reviewed by the applicable education provider and/or accrediting body and assigned a set amount of credit worthiness for completion of activity (in clock hours or other specified time period); provide a certificate or record

of participants amount of credit earned from activity; provide information regarding subject matter or content covered within activity so that CCB may review and award applicable amount of CCB CEUs. Examples include: post-session recordings of webinars, CCB approved magazine quizzes, or completing readings in *The Report on Medicare Compliance*, among others.

The distinction of "live" versus "non-live" credit is important when renewing your CCB certifications and when applying for a CCB certification exam. In either situation, at least half of your required CCB CEUs must come from live events or trainings. For certification renewal, that means at least 20 of the 40 required CEUs must be from live events earned within the two-year renewal period. You are welcome to submit more than 20 live CEUs to meet the 40 required for renewal, however you cannot have less than this amount.
