

SCCE & HCCA Salary Surveys and certification

Earlier this year, SCCE® & HCCA® surveyed compliance and ethics professionals on their compensation. If you haven't seen the results yet, not only does the survey provide some detail on how your compensation ranks based on title, organization size, and years of experience, but it also provides some interesting data surrounding the connections between certification and salary. For example, you can learn about average total compensation by certifications held, type of organization, and more.



A common benefit of professional certification is increased compensation. According to the Bureau of Labor Statistics, "Generally, earnings for workers with a credential were about one-third higher than earnings for those without one". The data in the SCCE & HCCA Salary surveys show a strong correlation between certification and higher levels of compensation in most cases.

Update to Individual Accreditation Application Submission Process

As you already know, Compliance Certification Board (CCB)[®] accepts compliance related continuing education from any organization as long as it meets CCB subject area requirements. However, effective January 1, 2023, CCB will no longer be accepting the paper, hard copy of the Individual Accreditation Application submitted via email, fax or mail to CCB. Individuals will need to complete and submit the Individual Accreditation Application through the current online process as follows:

Log into your online account > Account Dashboard > Scroll down to CEUs > Click Add CEUs > Submit an Individual Accreditation Application

As part of your submission, you need to attach supporting documentation that provides detailed content information, such as an agenda, certificate of attendance, etc. CCB Accreditation Specialists will then review the application and program information and determine whether the content meets CCB requirements for CEUs.

The change in this process will result in a quicker review time, resulting in you receiving the appropriate CEUs into your account in a timely manner.
